

## Wickham Market Youth FC Registration Form 2021/2022 Suffolk Youth Football League



The Committee and Managers of Wickham Market Youth FC thank you for your continued support of, and involvement in, the football club and all it represents in the community.

For the season 2021/2022 the fee for subscription has increased

Subscriptions are made up of 2 parts -

- Registration Fee: This is the cost of registering the players with the South Suffolk Youth Football League, payment of insurance premiums and other administration costs.
- Club fees: This is the cost for goods and services required to run the teams. e.g. referees fees, hire of winter training facilities, match balls etc.

The subscriptions this year will be made up of a Registration Fee of £30 and Club Fees which are notionally set at £90 but varied depending upon the age group.

This form is the Registration Form that allows a young person to play in the league. Before completing this form please read the information below which details the rules, methods of payment and the latest date by which payment must be made. Please also sign the Gift Aid Declaration as this has the potential of increasing our income and reducing subscriptions next year.

### **Rules of Registration:**

All players must have fully paid their Registration Fee before they can play. This is essential to ensure they are recognised by the League and are properly insured.

### Proof of Age ID:

# A copy of the players Passport or Birth Certificate must be provided as proof of age ID to ensure player is in correct age group

All players must have paid their club fees by the dates given in their age group, if not they will not be able to play.

Club fees can only be refunded or reduced when agreed by the club committee.

This form must be returned to your Age Group Manager.

#### Payment terms:

Under8's and Older: On submitting this form. The Subscription fee can be made as a single payment of £120 no later than 31<sup>st</sup> August. Payable to your age group manager.

Under 7s must pay their Registration Fee of £30 on Submitting this form. Following that they can pay £3 per match and training session

Cheques should be made payable to Wickham Market Youth Football Club

### **Booking Fines:**

If a player receives a booking fine within the Season this is also payable to their Age Group Manager. If this is not paid within a month of the booking they will be unable to play.
